Relief Operations: Food, relief funds, medical supplies, and equipment. Responded to four major disasters in 2015: The earthquake in Nepal, drought in Kenya, floods in India and the refugee crisis in Europe. Relief supplies were sorted, packaged, and shipped. We shipped 23 containers to Antigua, Dominican Republic, Ecuador, Haiti, Honduras, Kenya, Nicaragua, Nigeria, Panama, Ukraine, Zambia, and Zimbabwe. We supplied medicines, vitamins, and medical supplies to clinics, hospitals and short term mission teams all over the world.

Water Development - HHI drilled 153 clean water wells in 2015. We completed well number 792. New wells were completed in Ethiopia, Haiti, Ghana, Zambia, Zimbabwe, and India. In addition, Sawyer and Tiva water filters were provided where successful water wells could not be drilled

Agriculture Aid and Education - In 2015 we hosted 106 Sustainable Agriculture workshops in 13 countries and 5 states in the US.
